FIRST CALL – NOTES FROM THE FRONT

'TIS THE SEASON TO BE VERY, VERY CAREFUL

In this newsletter we talk a lot about the VA, Congress, Administrations past and present, and the Department of Defense, all in the context of how serving military, veterans, and their families are faring in their current service and in receiving the benefits that they have earned, all relative to existing law.

We also talk a bit about those who do not contribute: the general public that ignores the plight of current and past military members and their families. The corporations that refuse to hire veterans, reservist and guardsmen and women because of their ongoing military obligations or because of some fear that they will "go postal" (sorry USPS) in the workplace.

We probably do not talk enough about the few among the public and the few corporations that step up every day and do their duty by our brothers and sisters, and there are a number of them.

Now we have the onset of the "giving season"—the time between now and the first of the year—when all of us receive a snowstorm of mail requests for contributions. We have our phones rung incessantly by calls for contributions from, according to our caller IDs, "Out of Area", unidentified 800 numbers, "PPP", and blanks. Our mailboxes are filled with such requests, often contained in elaborate mailings with gifts, "please-don't-cash-this-one" checks, mailing labels, etc.

It is time to talk about another group.

Let's talk about the myriad charities and non-profits who distribute their largesse to military, veterans and their families—

Or so they say.

There are many charities and non-profits out there who do wonderful work for veterans, and they deserve our support. There are others who do some good work but don't manage our contributions wisely. There are some who do minimal good work—just enough to qualify themselves as veterans charities—and then use our funds, at least in part, to enrich themselves.

And there are those who neither serve us, give to us, nor even ignore us, rather they attempt to steal from us, or at best, get our money and use it for purposes other than that which was stated.

We all want to help. Veterans give more than any other group to veterans' charities. We don't want to turn down those who really help our brothers and sisters and who do really good works.

The question is, how can we know? We want to trust these people, and of course that is what the scammers are counting on—trust. But as Reagan said, "...trust, but verify". How does one verify?

I was inspired to write about this problem by several recent stories involving charities that were out and out scams. The most notorious recent example of one of these frauds is "The US Navy Veterans Association" and its CEO, or thief-in-charge, Bobby Thompson, who used millions donated for the use of Navy Veterans to enrich himself and a few accomplices, and who contributed some of those contributions to his favorite politicians and PACs. Bobby is on the run, and Bobby's accomplice, Bianca Contreras, is serving 7 years on multiple counts.

I was also inspired by receiving the first of the season's solicitations from an organization that says that it helps vets. This organization, (which I was not going to name but it is all in the public record) **Help**

Hospitalized Veterans, says that it helps vets under medical care by giving them useful recreational activities to pursue. I was not convinced, but I was curious and was willing to consider them.

My questions about these charities are always:

1. What does it do with its money? Does it really do what it says?
2. How well does it handle my contribution? What percentage gets to the vets?
3. Is what the vets get useful? Do they get any lasting benefit from it?
4. How much does the charity pay its principals? Its fundraisers? Its board?
5. Who is on the board, either as members or advisors? Do I know anything about them? Are they active or figureheads? Are they relatives of the principals?
6. So as not to be biased, the last question is: What do others say about this charity? Are there complaints? Are the complaints valid? *I use the charity's name and the words "scam" and/or "fraud" for a Google search.*

I need to assess not only how good this particular charity is that is asking for my money, but also to evaluate it against comparable charities. If I only have so much to give, to whom should I give it to get the best return for veterans?

Fortunately there are places to get fairly good answers to these questions. Let me share with you what I do with every one of these. It takes a little work, but you can determine which of the charities begging for your support is worthy of that support. If you only have so much to give, and I suspect that is the general case, how can you make your gift count the most?

First and foremost, take a deep breath and wait. Don't immediately write a check and don't round file the request. You have time, and so do they. Despite the fact that the message may request "Urgent help!", and imply that more veterans will be sleeping under a bridge this very night, or going to their maker far too soon if you don't "SEND THAT CHECK NOW".

Don't send it now.

I make a stack of all the requests for about a month, then I set aside a few hours and go through them, and I read every one thoroughly, including all of the fine print on all of the enclosures in the mailing. These requests are initially going one of three places—the "maybe" pile, the "check further" pile, or the round file.

The one's I have donated to before automatically go into the "maybe" pile. They are candidates but I want to make sure the rationale I used for giving before is still a sound one. There is no "yes" pile yet.

The ones who sent me a flag, a blanket, or any other bulky gift go into the round file. If they can spend my donated money for that junk then I don't want to feed that horse. (By the way charities, I don't use handwritten mail much anymore so please stop sending mailing labels).

That leaves those whom I have never heard from before.

Now I go to those organizations that can help me the most in analyzing each charity and its request, which are: Charity Navigator, Guidestar, The Economic Research Institute, and The American Institute of Philanthropy.

Let's use a couple to help us:

CharityNavigator: This is the first one I go to <http://www.charitynavigator.org>. Enter your charity in the Search area; you may get more than one organization in response. Click on the name of your charity. (note the "star ratings" at the right hand side - 0, 1, 2, 3, or 4 out of 4).

You will be presented with outstanding summary data. of particular interest are:

Some **overall ratings** which in the case of my mailing were 1 star overall, and 0 stars for financial—huge red flags.

"Leadership" which shows names, titles and compensation (base only) both in dollars and as a percentage of total Expenses.

"Charities Performing Similar Types of Work" which gives you some good alternatives to compare this charity to, along with their overall "star rating".

The site tells you at the bottom how they calculate the scores. Also, you can place a check mark by charities of interest and compare them side by side. You can even capture these charities in a personal "My Charities" file so that they are easy to get to when you come back for future checks.

Not all charities are included on every analysis website so if I still need information or just want more I go to:

Guidestar: Go to <http://www2.guidestar.org/> and register—it's free. Type the name of the charity into the "Search" box. You may get the offer of several

different charities with similar names, Find yours and when your charity's info page comes up, it will contain a number of tools for you to judge about this charity. Read it thoroughly; note the reviews and "star ratings".

The greatest source of information is the charity's IRS Form 990. These are useful if you cannot make up your mind from the summary information. You can acquire them at the Guidestar site by clicking on the "Forms 990 and Docs" tab and you will see a listing of the charity's 2010, 2009, 2008 IRS submissions. Download their latest, and if you wish, the others; now you have a goldmine in your hands.

When the Form 990 downloads the first place I go is to Schedule J "Compensation Information" and find out how much they pay their principals, not just their base but everything. In the case of my mailing, the Director gets over \$250K a year; last year received \$388K. Three others got a base pay of nearly \$200K.

If this charity were in New York City or Washington DC that might be reasonable depending on a lot of other info including comparable salaries with other national charities, but this one is in a small town in California and this becomes a red flag.

Because I downloaded the two previous years also I found that the previous year they paid both the old and the new Executive Director over \$250K each, and paid the retiring Executive Director in addition just under \$2M (that's right "M") in "deferred compensation" as part of a new retirement scheme apparently cooked up 6 weeks before his retirement.

I'm out of here! Anyone who is supposedly helping veterans and not himself doesn't take that kind of compensation, and he has been taking it for over 30 years! So by using just these two sites I have made my decision—[round file!](#)

How did my research answer my six questions?

1. It does give some of its money to veterans, and it does give in line with its mission statement.
2. Too low a percentage goes to veterans. They say 64% but it is not clear what goes into those costs.
3. I question the usefulness of its donations, since the craft kits it provides seem trivial compared to the needs of those vets.

4. It pays its principals a bundle, and some of its board members get paid as well. It pays its fundraisers a lot of money to produce the mailings and the donations, and I cannot determine the relationship of the principals in those firms to the principals in the charity.
5. I don't know the board members and cannot find out much about them. They don't seem active.
6. After answering those five I found:
 - a. A 2008 New York Times article mentioned my charity and its sister charity, both run by the same Director, "An Intolerable Fraud".
 - b. Congress cited them as examples of frauds on veterans and their supporters. (Had I done this search first it would have saved time, but I try to avoid being biased by others' opinions.)

Economic Research Institute: If you want quick info on charity directors' salaries and regional comparisons go to <http://www.eri-nonprofit-salaries.com/index.cfm> .

The **American Institute of Philanthropy** <http://www.charitywatch.org/> is another good watchdog site, although I have not used them as much.

Had I sent that check it I would have been helping to perpetuate the fraud. Be careful out there. There are charities that deserve your help. Use CharityNavigator to find some good veterans' charities that are worthy of your support and be very cautious with the mailings.

Full disclosure: lately I have been limiting my own giving to Fisher House (4-stars), National Military Family Association (4-stars), National Veterans Foundation (3-stars), Army Emergency Relief (3-stars), Vietnam Veterans Memorial Fund (4-stars), and, of course, Veterans United For Truth (listed but not long enough to earn any stars). I don't give to all of them all of the time (except VUFT), but I am quite comfortable with giving to this list as often as I can.

VCS - VUFT LAWSUIT UPDATE:

STATUS OF OUR CLASS ACTION LAWSUIT

STILL NO CHANGE—DID SOMEONE FROM THE VA COACH THE COURT ON THE "DELAY UNTIL THEY DIE" PROCEDURE? We believe that the Ninth Circuit panel correctly resolved all of the issues, even those on which they sided with the defendant, and that a rehearing is not necessary.

We reported the VA's claim that we have no constitutional right to our benefits. I am no lawyer nor am I a Constitutional scholar, but it just makes sense to me as a citizen that all citizens have a constitutional right to the protections and the benefits of all US laws. How can veterans be singled out as being different? Tell me, am I being naïve? Does one have to have a law degree to understand his or her status as a citizen? Should we have to have such training? Is that what we have come to, government by hidden meanings and complex understandings of occult doctrines?

The VA also claims "sovereign immunity", a concept that most executive branches enlist from time to time to avoid responding to the legal challenges from us as citizens. I thought that we got rid of the "sovereign" and his right never to be challenged by "ordinary persons" in that war we had from 1775 to 1781. In fact, we got rid of the concept of "ordinary persons" and "extraordinary persons". How does "sovereign immunity" jibe with the "right of the people to peaceably assemble, and to petition the Government for a redress of grievances"? Again, am I being naïve when I question this? Would someone please tell me where I am wrong? [Ed.]

Sandy, I enjoyed your editorial. Listen, I try forwarding your newsletter to other veterans but frequently get the complaint that it's too left-wing liberal, and too damn depressing. I think it would maybe help if you more liberally spattered your newsletter with some of the good news associated with life in the military, maybe add some stories about heroism, etc. It's just a thought, but I have to admit it's hard to read your newsletter without coming away either angry or depressed or both. I think it would still be within the mission of VUFT to increase the reporting of good stuff too. Anyway, keep up the fight, Terry P. Rizzuti 10/3/11

Terry, I hear your message about reporting more of the good news, but the purpose of the organization is to wrestle with the VA and the rest of the government over military and veterans' issues. Our job is to fight for serving military, veterans and their families. We have been in the federal courts for more than four years doing just that, and against incredible opposition from the VA, the Department of Justice, and from within the courts themselves.

I, too, am inspired by stories of heroism and the good side of life in the military but so many other publications and websites cover those issues almost exclusively. What they don't often cover is what is going wrong. I subscribe to a number of newsletters and websites that cover the subjects you mention. After much deliberation we have decided that we don't need to repeat what they already do quite well.

Our membership--conservatives and liberals alike--asks us to report on those stories that get buried by the mainstream press, and sadly often by the publications of the national veterans' organizations. They too get angry and depressed sometimes when reading what we report, but they say that that incites them to action, whereas most of the other stuff merely lulls them into complacency. That fits our purpose exactly.

If we can inspire someone to reach out to a veteran or to a military family and to lend a helping hand, then that is our mission. If we can inspire someone to get angry and to contact their legislator at the state or federal level and demand action, then that is our mission. If we can inspire someone to oppose those in their home town who want homeless veterans run out of town instead of helping them find jobs and shelter, then that is our mission.

I am particularly incensed by the major organizations like the Legion and the VFW who echo administration (Republican and Democrat) feel-good stories about the military and veterans and almost never mention the pain that so many serving military, veterans, and their families are suffering at the hands of the bureaucracy, and sadly often at the hands of their fellow citizens.

My reporting makes me sad and angry too. In addition to what we in VUFT are doing as an organization, the editorials are the one small way that I can help make the issues known to 10,000 or so subscribers and other recipients.

The fact that you pass these on is really important, and the feedback is welcome.

I am personally a liberal but I try to cover all aspects of our mission problems, regardless of the source. I quote liberally (no pun intended) from the mainstream press including Fox News and the Washington Times. The mainstream press is, despite protestations to the contrary, largely conservative, and seems to support the government in all matters military, as do the major veterans' organizations. I am not sure why but I suspect it is, in part, so that they do not jeopardize their access to Congress and the White House. (Oddly the only time the major vets' organizations got cut off was during the latter part of the Bush II presidency). We have to learn that we can support the military without supporting a militaristic foreign policy and still be fully red-blooded patriots.

My approach to discussing and reporting on these problems, which I hope is reflected in the editorials, is really a conservative one, which is that we have made a commitment so let's keep it. It should please conservatives that we are fighting just the kind of governmental bureaucratic inertia that they rightly bemoan every day.

I would welcome input from any conservative who wishes to present another point of view from the one that I present each month. These subjects are important and are getting short shrift with the public. Liberals and conservatives ought to be able to have an adult conversation on these subjects and ought to be able to put pressure, somehow, on the people who are neglecting those whom we liberal and conservative veterans support every day.

Making people angry, I guess, is our mission in addition to fighting those who are the cause of their anger. I'll leave making people feel good to someone else. At my age I don't have time to do both, and I think you can tell which I think is more important.

Please feel free to share my sentiments with any of your friends who might be interested in the reasons behind what we do. I hope it will help them to understand that the time for fighting is now, and that fighting of any kind is seldom uplifting or cheerful. Sandy (10/3/2011)

AFTER 10 YEARS SOMEONE FINALLY ASKS "WHA'SUP?"

LAWMAKERS VISIT AFGHANISTAN TO UNDERSTAND VETERANS' NEEDS

WASHINGTON — Bagram Air Base in Afghanistan showed freshman Rep. Jeff Denham, R-Atwater, Calif., a hint of what's to come in a war whose costs will keep accumulating for decades. Accompanied by four House colleagues, three of them doctors, Denham spent last weekend touring Bagram and other Afghanistan bases. Although brief, the trip put the lawmakers face-to-face with the war's extended health-care price tag. "It's obviously going to be a huge expense," Denham said Thursday. "It's undefined, but the one thing that is defined is that we have to take care of the veteran."

The bills already are piling up. More than 513,000 veterans of the Iraq and Afghanistan wars had filed for disability benefits as of last year. Some of these war-disabled are obvious, such as the approximately 1,600 who have had one or more limbs amputated. Some wounds are hidden, such as those diagnosed with post-traumatic stress or traumatic brain injury. Nearly one in five of the more than 2 million veterans who have served in Iraq or Afghanistan suffer from mental health conditions, according to a study released earlier this month by an advocacy group called Veterans for Common Sense.

WEAK CONGRESSIONAL STAND AGAINST VETS BUDGET CUTS

The American Legion is disappointed with the “tepid” stand taken by House and Senate Veterans Affairs Committee leaders against federal budget cuts that would compromise the welfare of military veterans. On Oct. 18, a letter to the Joint Select Committee on Deficit Reduction (the “supercommittee”) signed by the chairmen and ranking members of the House and Senate panels was released that has disturbed leaders of the nation’s largest veterans service organization. While the letter opens with the statement, “Never before in times of fiscal crisis have we balanced the budget on the backs of America’s veterans, and we should not do so now,” attachments to the letter propose a number of budget cuts directed at the Department of Veterans Affairs (VA), some of which, according the Legion, contradict that statement. The cuts proposed in the joint letter include elimination or reduction to a number of benefits, including pension, disability compensation and education payments.

CONGRESSMAN GARAMENDI RELEASES A COMPREHENSIVE BREAKDOWN OF DEFENSE SAVINGS SUPPORTED BY BIPARTISAN DEFENSE EXPERTS

WASHINGTON, DC – At Thursday’s House Armed Services Committee hearing on “The Future of National Defense and the U.S. Military Ten Years After 9/11,” Committee Member Congressman John Garamendi (D-Fairfield, CA) mentioned a matrix his office compiled of proposed Defense savings offered by experts across the political spectrum. Today Congressman Garamendi released the list to the public at the request of both Republican and Democratic Members of Congress and staff.

“Congress will have some tough choices to make in the weeks ahead, and clearly Defense spending is on the table. This matrix of possible Defense Department savings is compiled from proposals made by Think Tanks ranging from the far right to the center and the far left. It can help us find responsible defense savings to reduce the deficit while ensuring America’s national security,” Congressman Garamendi said.

Garamendi added, “Safeguarding the sustainability of our nation’s prosperity and security, while remaining true to the values that characterize us as Americans, calls for a focused, disciplined, and agile military. It also requires a strong and unshakeable economy and a well-informed and supportive citizenry.” “We in Congress have a responsibility to be good stewards of the public trust, treasury, and national defense,” Garamendi continued. “I am not suggesting I support all these proposals. I do, however, want to make sure we use the best available information to make strategic budget choices that will strengthen our nation’s prosperity and security.”

OBAMA’S FAVORITE THINK TANK: CUT THE ARMY, FORGET COUNTERINSURGENCY

The Obama administration’s favorite defense think tank was once a hothouse of counterinsurgency theory. But now that the government is trying to crawl out of its massive debt, the Center for a New American Security is less about big ground conflicts and more about how to shrink the defense budget. First on the chopping block, according to its forthcoming blueprint for defense cuts: counterinsurgency. Next: the Army and Marines who wage it.

“Extended counterinsurgency operations” are passé once the U.S. draws down in Afghanistan, says Nora Bensahel, a defense expert at CNAS, as the think tank is ubiquitously known in Washington. “We’re judging that a less-likely scenario.”

On Friday, CNAS will release a dour report called “Hard Choices: Responsible Defense in the Age of Austerity,” which looks at various scenarios for how to cut defense. Those scenarios range from a relatively easy \$350-400 billion over ten years, which the Pentagon has been prepping for all year, to the “high risk” option of cutting up to \$850 billion over a decade — which will happen automatically if Congress and the White House can’t agree to a comprehensive deficit fix by January 15. What they all have in common is that the Army and Marines are in for a world of hurt.

IRAQ MAY END LEGAL IMMUNITY FOR US TROOPS

BAGHDAD -- The possibility that some U.S. troops would remain in Iraq past the current Dec. 31 withdrawal date appeared all but doomed Wednesday as Iraqi political leaders ruled out any special legal protections for military trainers who stay behind.

U.S. officials, who have been advocating a continued presence past the withdrawal date set in a 2008 agreement, held out hope that some sort of accommodation might still be reached.

But Iskander Witwit, the ranking member of the Iraqi parliament's defense and security committee, said negotiations are now over, and that U.S. trainers would be invited to remain only if U.S. officials drop their insistence that the Iraqi parliament grant them immunity from prosecution in Iraq - a standard feature of U.S. status-of-forces agreements around the world.

PENTAGON DOESN’T KNOW WHERE THE MONEY IS GOING

The Defense Department, which has promised to publish a reliable account of how it spends its money by 2017, has discovered that its financial ledgers are in worse shape than expected and that it will have to spend billions of dollars in the coming years to make its financial accounting credible, the Center for Public Integrity reported Thursday.

The U.S. military has spent more than \$6 billion to develop and deploy new financial systems, but the effort has been plagued by significant added overruns and delays, defense officials told the CPI, a nonprofit investigative news organization.

The Government Accountability Office said in a report last month that although the services can now fully track incoming appropriations, they still can’t demonstrate that their funds are being spent as they should be.

U.S. TO HAND OVER IRAQ BASES, EQUIPMENT WORTH BILLIONS

WASHINGTON -- With just over three months until the last U.S. troops are currently due to leave Iraq, the Department of Defense is engaged in a mad dash to give away things that cost U.S. taxpayers billions of dollars to buy and build.

The giveaways include enormous, elaborate military bases and vast amounts of military equipment that will be turned over to the Iraqis, mostly just to save the expense of bringing it home.

"It's all sunk costs," said retired Army Maj. Gen. Paul Eaton, who oversaw the training of Iraqi soldiers from 2003 to 2004. "It's money that we spent and we're not going to recoup."

There were 505 U.S. military bases and outposts in Iraq at the height of operations, said Col. Barry Johnson, a spokesman for U.S. forces in Iraq. CLASS ACTION SUIT SEEKS \$4.9 BILLION IN DAMAGES FROM TRICARE DATA THEFT

An Air Force veteran of the first Iraq war and a military spouse and her two children have hit the Defense Department with a class action lawsuit seeking \$4.9 billion in damages from the theft of a computer tape containing personal and sensitive health information from the car of an employee of Science Applications International Corp., a contractor with the TRICARE Health Management Activity. The company was not named as a defendant in the action.

The suit, filed Monday by the law firm Shulman, Rogers, Gandal, Pordy & Ecker of Potomac, Md., seeks \$1,000 in damages for all 4.9 million TRICARE beneficiaries whose records were on the computer tape stolen Sept. 13 from the SAIC employee's car in San Antonio. TRICARE and Defense Secretary Leon Panetta are named as defendants.

When the Veterans Affairs Department discovers a loss, theft or exposure of this kind it routinely offers credit monitoring services and up to \$1 million annually in identity theft protection at a cost per veteran of \$29.95 a year. At that rate, it would cost TRICARE \$146.8 million to provide credit monitoring services to 4.9 million people.

MILITARY RETIREES' COLA TO RISE BY 3.6 PERCENT

After two years of having no annual adjustment, military retirees will receive a 3.6 percent cost-of-living adjustment effective Dec. 1.The money will first appear in January checks.

The same percentage increase will apply to Social Security, federal civilian retired pay and other government entitlements linked to the Consumer Price Index. The retiree increase is larger than the 1.6 percent pay raise expected on Jan. 1 for the military. Some of the nation's biggest banks and mortgage companies have defrauded veterans and taxpayers out of hundreds of millions of dollars by disguising illegal fees in veterans' home refinancing loans, according to a whistleblower suit unsealed in federal court in Atlanta. Sun Life and Health Insurance Co., which provided the long-term disability plan for Riley's employer, began paying Riley benefits in January 2005. But two years later, Sun Life learned Riley also received veterans' benefits for the disease that developed while he was serving in Vietnam War during the early 1970s. REBUILDING SOLDIERS TRANSFORMED BY WAR INJURIES

Improvements in medical care and equipment mean fewer troops are dying on the battlefield. But more troops are returning home severely wounded, with injuries that require lifelong care and cost millions of dollars in medical bills. On Thursday's *Fresh Air*, veteran combat reporter David Wood talks about some of the challenges that severely wounded soldiers face when they return from Afghanistan and Iraq. Wood is the author of a [new 10-part series](#) for The Huffington Post called "Beyond the Battlefield" that examines some of those challenges and setbacks.

Wood tells *Fresh Air's* Terry Gross that fewer U.S. troops die outright on the battlefield — because of protective equipment and better medical care. But more Americans are being wounded, and their injuries are more "severe and complex." The number of American soldiers who lost at least one limb doubled from 2009 to 2010, and the number of triple amputees has nearly doubled, he says. WAR VETERANS PROUD BUT STRUGGLING AS CIVILIANS

Veterans of Afghanistan and Iraq are having greater difficulty returning to civilian life than veterans from previous eras but remain proud of their service, according to the results of a Pew Research survey released Wednesday.

The rare survey of former service members <http://pewresearch.org/pubs/2111/veterans-post-911-wars-iraq-afghanistan-civilian-military-veterans> says veterans have found the cost of combat to be high in personal and family anguish, and less than a majority of those surveyed, 34 percent, say both conflicts have been worth the fight. Fifty percent say Afghanistan was worth it; 44 percent say the same of Iraq.

"So we have this experience of stress [under fire] that can cause growth or injury," said Ward Casscells, the chief medical officer at the Pentagon from 2007-09. "Our task now is to find better ways of screening out those who have a high chance of injury and learn to catch them as they fall."

Forty-four percent of those surveyed say their adjustment to civilian life has been difficult, compared with the 25 percent of veterans surveyed from previous eras. Half of those who served in combat report signs of post-traumatic stress, and 75 percent report living with nightmares and flashbacks from their combat experience.

LEGACY OF DECADE AT WAR: 1 MILLION JOBLESS VETS

WASHINGTON — Democrats and Republicans rarely agree on anything in Washington, but there's a growing bipartisan sense that the private sector will have to do much more to help ease chronically high unemployment among veterans returning from Iraq and Afghanistan. In August, President Obama called on businesses to hire or train 100,000 unemployed veterans by the end of 2013. Microsoft answered that challenge with a pledge to train 10,000 of them. Now, as part of his \$447 billion jobs package, Obama wants Congress to approve a plan that would provide businesses with a tax credit of \$2,400 to \$9,600 for each veteran they hire, the amount depending on whether they're disabled and how long they've been unemployed. A million veterans already are unemployed, and more than a million are expected to leave the military by 2016.

COALITION OF COMPANIES VOWS TO HIRE 25,000 VETERANS, SPOUSES

NATIONAL GUARD AND RESERVE ACTIVATED AS OF OCTOBER 11, 2011

This week the Army, Navy, Air Force and Marine Corps announced a decrease in activated reservists, while the Coast Guard announced an increase. The net collective result is 613 fewer reservists activated than last week. At any given time, services may activate some units and individuals while deactivating others, making it possible for these figures to either increase or decrease. The total number currently on active duty from the Army National Guard and Army Reserve is 69,463; Navy Reserve, 4,629; Air National Guard and Air Force Reserve, 10,807; Marine Corps Reserve, 5,644, and the Coast Guard Reserve, 768. This brings the total National Guard and Reserve personnel who have been activated to 91,311, including both units and individual augmentees. NEW BILL TO PAIR DOGS WITH VETERANS

Much of the attention in Congress is focused on deficit reduction and partisan gridlock, but some bipartisan bills are still making progress. Yesterday the House unanimously passed a package of veterans' health care legislation (H.R.

2074), and included in the final bill was the Veterans Dog Training Therapy Act (H.R. 198), introduced by Rep. Michael Grimm, R-N.Y., which will help pair vets with pets and is good for both soldier and canine.

The legislation would create a pilot program for training dogs as a form of therapy to help treat veterans suffering from post-traumatic stress disorder and other post-deployment mental health conditions. The dogs could come from shelters, and after training, they would become service dogs to assist veterans with disabilities.

ADD-ON ~ STUFF OF INTEREST

SERVICEMEMBERS' GROUP LIFE INSURANCE TRAUMATIC INJURY PROTECTION PROGRAM (TSGLI)

Every member who has SGLI also has TSGLI effective December 1, 2005. This coverage applies to active duty members, reservists, National Guard members, funeral honors duty and one-day muster duty.

This benefit is also provided retroactively for members who incurred severe losses as a result of traumatic injuries incurred between October 7, 2001 and November 30, 2005, if the injury was incurred in Operation Enduring Freedom (OEF) or Operation Iraqi Freedom (OIF), regardless of whether they had SGLI coverage at the time of their injury.

Effective October 1, 2011, TSGLI will be payable for all qualifying injuries incurred during the period October 7, 2001 to November 30, 2005, regardless of where they occurred, and regardless of whether the member had SGLI coverage at the time of the injury. The Veterans' Benefit Improvement Act of 2010 removes the requirement that injuries during this period be incurred in Operations Enduring or Iraqi Freedom.
